Rebate limit for a Qualified Contractor is based on PREVIOUS YEAR'S contributions to the NIPDI Industry Promotion Fund.

## What is the FCAI Rebate Program?

This program is designed to make *safety equipment and professional clothing more affordable.*

Some of the equipment and clothing sold through the program includes:



- *respiratory items*
- *personal protection gear*
- *fall protection gear*
- *extension cords*
- *drop cloths and more!*

## Who Can Participate?

Only *Qualified Contractors* are eligible to take advantage of FCAI's unique Rebate Program.

A *Qualified Contractor* is:

- *An FCAI Member*
- *Current with contributions to the Industry Promotion Fund*

## How much can I spend?

The Rebate Limit for a *Qualified Contractor* is based on the previous year's contributions to the Industry Promotion Fund. Rebate amounts are **50% off** approved purchases *up to your rebate limit.*

## How do I know my Rebate Limit?

## How can I participate?

All sales must be placed through FCAI Approved Vendors [See list on the back of this brochure]. These vendors submit your invoice to FCAI. After payment is made in full, you will receive 50% of your subtotal back on *Approved Items.*

All *Approved Items* are listed in FCAI's **Rebate Product Price Book**. Each Approved Vendor receives this book along with information on participating in the Rebate Program.

Safety and clothing products *can be purchased from more than one Approved Vendor.* However, those products not listed in FCAI's **Rebate Product Price Book** *must be approved by FCAI.\**

## What is an Approved Vendor?

An FCAI Associate Member that

- *Attends 4 General Membership Meetings & 4 Associate Member Meetings WITHIN 1 CALENDAR YEAR*
- *Pays annual dues IN FULL by January 1st*
- *Has no outstanding invoices over 60 days*

## How do Monthly Specials work?

Specials are offered from the 1st to the 15th of each month. Purchasing these specials **DOES NOT** affect your yearly rebate limit.

For example, if a contractor has a base rebate amount of \$1,000 and, he participates in each month's special — and spends \$26,000 in a year — *that contractor could get \$13,000 back from FCAI in Rebate Program savings!*

***That's your 50/50 rebate!***
